



ORDER OF THE LAW CLERK

Re: Rental Housing Regulation TNR 2/2013

Enacted under the Grammatical and Typographical Amendments Act TNS 1/2015 section 2.1

TNO 01/2016

BACKGROUND:

- A. On September 16, 2015 the Executive enacted the Housing Authority (Market Housing) Amendment Act (the “Act”);
- B. By letter dated January 7, 2016, legal counsel for the Toquaht government advised the law clerk that, after the enactment of the Act and through inadvertence, the Rental Housing Regulation TNR 2/2013 contains typographical errors;
- C. In accordance with section 2.1 of the Grammatical and Typographical Amendments Act TNS 1/2015, the law clerk may, by Order and on the advice of legal counsel to the Toquaht government, make an amendment to an enactment to correct a grammatical or typographical error in that enactment, provided that amendment does not in any way alter the intent of, or a right, duty or power provided for in, that enactment.

NOW THEREFORE THE EXECUTIVE ORDERS AS FOLLOWS:

- 1) The Rental Housing Regulation TNR 2/2013 is amended as follows:
 - a) section 1.2(d) is amended by striking out “10.4” and substituting “11.4”;
 - b) section 1.2(e) is amended by striking out “12.3” and substituting “13.3”;
 - c) section 1.2(g) is amended by striking out “Toquaht housing” and substituting “Toquaht social housing”;
 - d) section 1.2(j) is amended by striking out “13.3” and substituting “14.3”;
 - e) section 1.3(a) is amended by striking out “10.4” and substituting “11.4” in the definition of “applicant” in that section;
 - f) section 1.3(b) is amended by striking out the two instances of “Part 10” and substituting “Part 11”;
 - g) section 2.2(b)(iii) is amended by striking out “10.4” and substituting “11.4”;
 - h) section 2.2(b)(iv) is amended by striking out “12.3” and substituting “13.3”;
 - i) section 2.2(c)(ii) is amended by striking out “10.4(c)” and substituting “11.4(c)” and by striking out “12.4(b)” and substituting “13.4(b)”;

- j) section 3.1 is amended by striking out “building” and substituting “housing” in the heading of that section;
- k) Form HA-4 – Application for Spousal Tenancy in Schedule 1 is amended by striking out “Part 10” and substituting “Part 11” in the second line; and
- l) Schedule 5 – Offences and Penalties is amended as follows:
 - i. in column 1 of row 4 by striking out “Part 9” and substituting “Part 10”;
 - ii. in column 1 of row 5 by striking out “9.2” and substituting “10.1”;
 - iii. in column 1 of row 6 by striking out “9.3(a)” and substituting “10.2(a)”;
 - iv. in column 1 of row 7 by striking out “9.3(c)” and substituting “10.2(c)”;
 - v. in column 1 of row 8 by striking out “9.6” and substituting “10.5”;
 - vi. in column 1 of row 9 by striking out “Part 10” and substituting “Part 11”;
 - vii. in column 1 of row 10 by striking out “10.5(e)” and substituting “11.5(e)”;
 - viii. in column 1 of row 11 by striking out “10.7(a)” and substituting “11.7(a)”;
 - ix. in column 1 of row 12 by striking out “Part 13” and substituting “Part 14”; and
 - x. in column 1 of row 13 by striking out “13.3” and substituting “14.3”.
