## **PART 1 - INTRODUCTORY PROVISIONS**

### **Short title**

- 1.1** This regulation may be cited as the Emergency Preparedness Offences Amending Regulation.

### **Application**

- 1.2** This regulation makes amendments to the Compliance Notice and Ticket Regulation.

### **Definitions**

- 1.3** In this regulation,

“Compliance Notice and Ticket Regulation” means the Compliance Notice and Ticket Regulation TNR 2/2014.
