PART 1 - ORDER PROVISIONS

Short title

- 1.1 This Order may be cited as the Executive Order regarding addition of schedule 2 and schedule 3 to the lands registry forms regulation.

Definitions

- 1.2 In this Order,
- (a) “Act” means the Land Act;
 - (b) words or expressions defined in the Act that are also used in this Order will, except where the context requires otherwise or is otherwise indicated, have the same meaning as those words or expressions defined in the Act.

Order

- 1.3 In accordance with section 4.17 of the Act, the Executive orders that the following Application for Disposition be inserted into the Lands Registry Forms Regulation as Schedule 2.
- 1.4 In accordance with section 2.6(c) of the Act, the Executive orders that the following Fee Schedule be inserted into the Lands Registry Forms Regulation as Schedule 3.

General

- 1.5 This Order comes into force on the date it is enacted and has effect from the date the Act came into force.
